Axe-attackers seek mercy

Lawyers for three young men convicted of a brutal axe attack that left a teenager paralyzed argued against a Crown request to sentence them as adults yesterday.

Michael Levy, then 17, was attending a dance at Surrey's Tynehead Hall on Oct. 28, 2006 when he was punched, pepper sprayed and struck three times in the back of the head with a hatchet.

The attack, which severed Levy's spinal cord, left him clinging to life and permanently paralyzed.

Outside Surrey Provincial Court yesterday, Craig Sicott, a lawyer for one of the convicted teens said that a more lenient sentence of two years would be sufficient for his client.

The three could serve up to 14 years each if sentenced as

adults.

"Psychiatric and psychological examiners have stated that he has shown remorse for his actions," Sicott said, while acknowledging that the heinous nature of the crime will likely influence the judge's decision.

It could take until the New Year for sentences to be handed down, as one of the men is looking for a new lawyer. As young offenders, the three convicts cannot be named.
