Under the most incredibly difficult conditions – including NATO bombing, mercenary andings, Special Forces operations and the destruction of civilian infrastructure - the heroic resistance to imperialist conquest in Libya has continued.

All the corporate media lies claiming mass surrender, the fleeing of Libyan leader Moammar Gadhafi, the arrest of his sons and more have turned out to be nothing but lies and psychological warfare. After 159 days of bombing,

incredibly, the residence continues.

The continued resistance also exposes the lie so-called of the democratic "rebel" forces forces that have been set up by Britain, France and the U.S. to facilitate the imperialist invasion the oil-rich country. Meanwhile, arms have been

distributed by the Libyan government to the whole population - something a hated dictator would never do.

As in Iraq and Afghanistan, an arrogant declaration of U.S. victory and "mission accomplished" does not mean an end to local people's resistance, which takes many forms. The Libyan people have heroically withstood not only half a year of bombing, but also a hail of racist corporate media propaganda seeking to portray the U.S.-NATO military machine, both preposterously and once again, as great white liberators.

While resistance continues in Libya, we in the center of U.S. imperialism must continue our resistance to the criminal war there – even as the prolonged economic war against poor and oppressed people continues within the U.S.

An IAC-organized truth tour featuring Congressperson Cynthia former McKinney – who traveled to Libya to be an eyewitness to the U.S.-NATO attack - has built major opposition meetings in 21 cities across the

country. At each meeting, which was undertaken by a local coalition of forces, hundreds of anti-war anti-imperialist and and community activists attended.

> These meetings against U.S. war in Libya have been the largest series of antiwar meetings held in years. At the same time, the IAC has been in the streets, organizing protests across the country.

The U.S. war in Libya is a first aggressive step in the expansion of wars of colonial conquest in Africa. It means new U.S. threats against Sudan and Somalia. It means more belligerent targeting of other countries in Middle East, especially Syria and Iran.

The Ministry of Foreign Affairs has proceeded to withdraw its diplomatic personnel in Libya, where foreign intervention and the NATO military aggression have intensified the conflict and have prevented the Libyan people from advancing towards a peopliated and from advancing towards a negotiated and peaceful solution in the full exercise of their self-determination.

The Republic of Cuba does not recognize the National Transition Council or any other provisional authority and will only give its recognition to a government legitimately constituted in that country without foreign intervention and through the free, sovereign and sole will of the sister Libyan people.

other countries and has even violated the questionable resolutions imposed by the Security Council, in particular by attacking civilian targets, by funding and supplying weapons to one side, as well as through the deployment of operative and diplomatic personnel on the ground.

The United Nations has ignored the clamor of international public opinion in the defense of peace and has become the accomplice of a war of conquest. Events are confirming the early warnings of Commander-in-Chief Fidel Castro Ruz and Cuba's timely condemnation in the UN. Now it is better understood what the so-called "responsibility to protect" is for in the hands of the powerful.

Cuba affirms that nothing can justify the killing of innocent people.

To Stopwar.ca and the Canadian Peace Alliance

Ι

We in Mobilization Against War and Occupation (MAWO) are sending you this open correspondence to express the grave concerns we have with your organizing of the April 9th demonstration in Vancouver. Your approach and politics on this day were without a doubt against the spirit of building an antiwar, anti-occupation movement not only in Canada but throughout the world. Imperialist countries and their military fronts such as NATO are beginning to sink their teeth into Libya while continuing the brutal wars and occupations in Afghanistan, Iraq, Haiti, Ivory Coast, Somalia, Sudan, Palestine and beyond. This is a crucial time for the antiwar movement and we need an open and honest discussion or risk seeing further capitulation to the pro-imperialist political and military campaign against Libya.

The CPA's cross-Canada participation in the April 9th International Day of Action called by the United National Antiwar Committee (UNAC) in the U.S. was a breakthrough in cross-border unified action. We have been advocating for years that working with U.S. groups and coalitions is an essential aspect of a strategy to build a broad, united and effective antiwar movement.

Thousands rallied in New York and San Francisco, while coordinated rallies were held in 10 Canadian and 6 Pakistani cities, as well as demonstrations in Iraq on April 9th. These mobilizations built on the momentum of other successful coordinated rallies called by the ANSWER Coalition on March 19th. This broadly coordinated action has been missing for too long from the antiwar movement in Canada, and we fully endorse its continuation on a hopefully increasingly frequent basis. However, based on the events during the rally organized in Vancouver by Stopwar.ca and the CPA's public statements regarding the current crisis and NATO bombing in Libva, we are concerned that the political direction of these actions in Canada is unclear at best, and could even be understood at worst as pro-war.

At the Stopwar.ca rally in Vancouver we saw that two speakers invited by Stopwar.ca spent 15 minutes justifying and advocating IN FAVOUR of the current NATO bombing of Libya. Do the following quotations from the Stopwar.ca rally really have a place at an antiwar rally occurring in the midst of a bloody imperialist campaign to intervene in a civil war and overthrow the independent government of Libya?

- "If you don't want war on Libya, what is your alternative?
- "He [Gaddhafi] has an unbelievable media machine, he spends billions and billions that tries to paint the picture that NATO is bombing Libyan people. NATO is not bombing Libyan people!"
- "This [the bombing of Libya] is not like Iraq, this is not like Afghanistan, this is not a foreign occupier coming onto our land!"
- "If you don't want those people [foreign forces] to get inside of Libya and you want to stop them you are saying, 'Let Ghadafi kill us!' "
- "You are giving us the wrong message. You are saying its okay for civilians to get killed but it is not okay for NATO to help us!"
- "Do you have a heart?!" (shouted at someone speaking against the bombing of Libya from the

At least 10 people in the crowd responded to these pro-war speakers by shouting, "Stop bombing Libya!" while one of the more vocal critics of the pro-war speakers who is a long-time social justice organizer was surrounded and closed in on by three Stopwar.ca marshals. Even after it was clear to everyone involved what these pro-war Libvans were advocating, the Stopwar.ca MCs invited yet another one to speak!

Stopwar.ca and CPA co-chair Derrick O'Keefe spoke at the end of the rally to confirm that they had invited these speakers knowing full well the pro-war message they were going to put forward. He said, "We invited the Libvan speakers who we've been in touch with even though there's a difference in opinion about NATO's intervention, we thought it was important for them to have their say." In fact, Derrick O'Keefe, and both of the Stopwar.ca MC's tried to justify this position to the rally, as if the pro-war position on Libya is somehow being unfairly under-represented. When Derrick O'Keefe said "We know its our job to stay on the streets and to bring the truth," this shouldn't mean the so-called "truth" that the government of Canada is putting forward by participating in bombing the Libyan people! Though Derrick O'Keefe mentioned that Stopwar. ca as a coalition had voted to oppose imperialist intervention in Libva, the time given to this supposed position was nothing compared to what was given to the pro-war Libyans. We must ask how Stopwar. ca can justify writing a statement which says they are "absolutely opposed to the NATO bombing of Libya, which is a shocking violation of the UN Charter and an act of war against a sovereign country" and then give such a huge amount of space to a pro-war message we can all hear 24/7 if we turn on CNN. FOX News, BBC or any of the other advocates of imperialist wars and occupations.

There is no justification for having pro-war speakers at an antiwar rally. There is no space for presenting such confusion in a public action that is supposed to be about taking a stand against war and occupation.

Unfortunately we have seen examples of this kind of behavior from Stopwar.ca over the past several years and in the weeks leading up to the demonstration. For instance, Stopwar.ca has invited speakers who advocate the overthrow of the independent government of Iran in the midst of an imperialist campaign demanding the same. They have also promoted other speakers who have compromised antiwar, anti-occupation political principles. Most recently, leading up to April 9th Stopwar.ca played an active role in weekly demonstrations organized by pro-war Libyans. In supporting these demonstrations Stopwar.ca showed a complete indifference and lack of responsibility for their actions as an antiwar coalition in the midst of a new war opening against the people of Libya.

Because of our experience in Vancouver we are concerned that similar events played out in other demonstrations across Canada. Did these other rallies also have pro-war speakers? The CPA, as an umbrella antiwar organization in Canada, has the responsibility to provide leadership and a clear political direction to its membership organizations, especially at such a crucial time.

We have read the statement released by the CPA "Support the Libyan people. Yes to freedom and democracy across the Arab World! No Military Intervention in Libya." The confused position that was presented at the April 9th demonstration reflects this confused statement, which concludes, "The best way to help the people of Libya is to show our solidarity with their struggle." Our role as antiwar coalitions is not to take sides in a civil war in an independent country under attack by imperialists, but to clearly oppose any form of foreign imperialist intervention which has never, and will never, benefit the people of that country. You can't have it both ways at once - to join in the imperialist campaign used to justify the bombings while saying that you oppose the bombings at the same time.

There is much to be learned from the coalitions that have organized rallies in the US since the imperialist campaign against Libva began, Through statements, as well as the March 19th, March 26th and April 9th mobilizations, organizations such as ANSWER, the International Action Center (IAC) and UNAC have taken a strong position against the current war on the people of Libya. The difference is that, in contrast to what we observed in Vancouver, in the US the actions of these antiwar and social justice organizations match their words. From the lead banners to the signs and rally speakers, to the UNAC report from NYC which stated, "The new war in Libya has given rise to a new movement, as the largest anti-war demonstration New York has seen in years took to the streets of Manhattan." There was no contradiction or confusion as they had the leadership to take a strong stance against imperialist intervention in Libya. This is an example for all of us to follow.

II

MAWO has been participating in the same efforts, in the spirit of anti-imperialism, cooperation, and antiwar movement building. Starting from even before the bombing of Libya began we have organized 5 forums and 3 rallies, as well as produced 2 buttons and launched a petition campaign, all against foreign intervention in Libya. We have also produced 3 antiwar newsletters filled with news and analysis to counter the lies being spread by imperialist media on Libya and the uprisings and mass movements in the Middle East and North Africa (MENA). Within this newsletter are ideas and statements we think are crucial at this time and are much more appropriate be said at antiwar rallies:

"There is no saving of human lives or any humanitarian intervention on behalf of the Libyan people that can be performed by imperialist powers. Indeed, this is such an obvious hypocrisy by these war mongers because none of those precious human values

mean anything to them. One, we haven't forgotten

the killings of millions of people in Vietnam, more than a million people in Rwanda, killings of more than one million people in Iraq just from 2003 until now, as well as hundreds of thousands of innocent people in Afghanistan, Pakistan, Congo, Nigeria, Sudan, Somalia and many other poor and sovereign countries by the very same imperial powers."

"This is a time to abandon all illusions that there might be anything progressive and human to overthrowing the Libyan government or helping the opposition in Libya through imperialist intervention such as sanctions, a no-fly zone or military attacks... The unfolding mass revolutionary movement and ousting of Mubarak and Ben Ali in Egypt and Tunisia have been a fresh struggle for anti-imperialist movements in the region. It certainly reversed the setback imposed on the working and poor people of the world through the occupations of Afghanistan and Iraq. What the great masses of North Africa and the Middle East need to see is not another Iraq but rather another Egypt."

III

Since our founding on October 29, 2003 MAWO has always endorsed and supported Stopwar.ca, the CPA and other groups whenever they have organized antiwar work. However, we are also clear that we don't feel that bringing occasional celebrity speakers and holding sporadic events not connected to consistent campaigns is enough to even begin scratching the surface of building a strong antiwar movement. This is unlike what we have seen in the

Libya:

War of Ideas Breaks Out International Action Center - Aug 31, 2011

By directing their enormous joint military and economic power against a poorly armed, nonindustrialized country of 6 million people, the imperialist states of North America and Western Europe have imposed a criminal regime on the Libyan people.

Part of Libya's continued resistance to this attempted imperialist takeover of an African state is the ideological struggle within the left and workers' movement internationally. The only legitimate position for the left in the imperialist countries is to support the Libyan resistance to imperialism, whatever form it takes.

As Libyans continue to battle the takeover, the U.S.-NATO forces may still come in on the ground. The new Transitional National Council regime, however, has already been invited to represent Libya in imperialist-dominated international bodies even as its armed gangs are massacring Libyans and the mostly sub-Saharan guest workers remaining in the cities it dominates.

The TNC is not a real government at present, but a racist gang of hoodlums and mercenaries looting homes and museums in Tripoli and other cities. This is fitting, as its U.S. and European Union masters aim to loot all of Africa as freely as they did until the 1960s.

Remember though that in Afghanistan in 2001 and in Irag in 2003, the imperialists won what appeared to be quick and easy military victories. But an active resistance movement has stalemated the U.S.-NATO occupation of Afghanistan. And the Iragi puppet regime is still shaky enough that the U.S. occupation will be extended. Reimposing colonialism in Libya may be no easier.

Air war, propaganda war

The U.S.-NATO forces' advantage can be easily explained. Libya's GNP was \$96 billion in 2010, much of it in oil production. The combined GNP of Western Europe and the United States was \$29 trillion, or about 300 times greater than Libva's. Much of Libva's wealth from oil sales was deposited in imperialist banks, which simply confiscated it when their campaign to destroy the Libyan

This enormous wealth advantage yields military dominance. The Pentagon has half the world's firepower. Britain, France, Italy, Spain and Belgium have a good piece of the rest. This hydra-headed giant faced Libya's tiny army.

The imperialist propaganda machine yields another monopoly of words and images. It demonized Moammar Gadhafi and his family. It disguised the TNC as a "democratic" movement, when it was a small collection of pro-imperialist Libyans, mercenaries, monarchists, reactionary religious forces and opportunist defectors from the Libyan government, with a narrow popular base only in the region around Benghazi.

The media exposed the decisive role of NATO forces only

U.S. where there is a constant effort by different political tendencies to improve and build new fronts against imperialist aggression. We have rarely spoken out publicly about the huge blocks and slander we have faced for years in our efforts to work in a united way either with Stopwar.ca or the CPA, but now is not the time to remain silent. Now is not the time to remain divided based on petty or sectarian differences, now is the time to learn from the people of the Middle East and North Africa as they rise up and counter the imperialist domination they have faced for decades. Interestingly and ironically, as a Canadian-based coalition, more so than in Canada, our efforts for unity have had a great welcoming by U.S. coalitions and social justice groups such as ANSWER, UNAC, IAC, the Stop War On Iran coalition, IFCO/Pastors for Peace and others.

We are making a strong call to Stopwar.ca and the

- 1- Stop taking the unclear middle of the road path and arm yourselves with a clear antiwar, anti-occupation platform by rejecting saying one thing and doing the opposite.
- 2- Organize an open, inclusive, broad and well organized public discussion on how to build a united and effective antiwar movement in Canada and world-wide.

We believe these are the only serious options in response to the current situation. Today in a joint letter the presidents of the United States and France and the prime minister of Britain declared, "there can be no peace in Libya while Muammar Gaddafi stays in power," "Libyans in cities like Misrata and Ajdabiya continue to suffer 'terrible horrors at Gaddafi's hands'," "it is impossible to imagine a future for Libya with Gaddafi in power," "To allow him to remain in power 'would be an unconscionable betrayal' of Libya's people," "So long as Gaddafi is in power, NATO and its coalition partners must maintain their operations so that civilians remain protected and the pressure on the regime builds," and finally "Then a genuine transition from dictatorship to an inclusive constitutional process can really begin, led by a new generation of leaders." All quotations are from the BBC, and the complete letter is in the Washington Post April 14, 2011. Isn't it clear what colonial powers are up to in Libya? Is this different than what the Libyan opposition or the pro-war Libyans that participated in your rally say? Where is this confusion of giving a big platform to pro-imperialist, pro-war Libvans coming from?

Let us discuss these issues out in the open. We cannot let the mistakes of April 9th keep us from moving forward. Those mistakes create confusion

after the TNC entered Tripoli. It probably did so because the imperialist military agencies then wanted credit for what they proclaimed was a victory.

In the Sept. 1 Workers World, Abayomi Azikiwe cites the International Business Tribune, the London Daily Telegraph and the Associated Press, all of which point out the decisive role of Britain's MI6 and special forces, U.S. and French special forces, U.S. air intelligence and heavy bombing by NATO in the battle for Tripoli. The truth is that without NATO leading the way, the TNC forces would never have made it out of Benghazi.

The Qatar-based agency Al-Jazeera has also given the news from Libya an anti-Gadhafi and pro-NATO slant throughout the last five months. Qatari troops are part of the TNC armed force that entered Tripoli on Aug. 21

There is another small contribution to imperialist war propaganda that deserves discussion. Political analysts who have an undeserved reputation of being progressive have brought the same arguments to a part of the left movement. These analysts only carry weight because their "leftist" argument coincides with what the imperial-

Following the Aug. 21 invasion of Tripoli, two such analysts were guests on the Democracy Now! news show, which is popular among progressives.

One "expert" was Juan Cole, a history professor at the University of Michigan. Cole argued that "Libya has reignited the flame of liberty in the Arab world." He claimed the TNC could enter Tripoli easily because it had popular support. Cole ignored the role of NATO's bombing, brib-

The other was Gilbert Achcar, a professor at the School of Oriental and African Studies in London. He chided NATO for allegedly first trying to broker a deal between the TNC and Gadhafi. He also presented the TNC as a legitimate popular leadership. Since March, Achcar has promoted the misleading idea that Libvans could "use' NATO to back a legitimate popular uprising without being owned lock, stock and barrel by the imperialists

Neither "expert" added that the NATO powers have waged this war for oil profits and a military foothold in

These and similar "experts" around the U.S. and Europe - who pretend to be progressive - are not acceptable as voices of the left and must be countered by hones anti-imperialist forces, just as one answers any imperial-

Fortunately, there is an attempt to mobilize anti-imperialist ideas — and action — in the United States, Former U.S. Rep. Cynthia McKinney has been on a North American tour organized by the International Action Center, bringing the truth about NATO's war against Libya. Most of these rallies have attracted between 200 and 500 people. Much support has come from the African-American community, which knows of McKinney's principled anti-racist and anti-war stand when she represented the people of her Georgia congressional district.

The tour is an example of how to build an anti-imperialist alliance that can answer the phony "leftists" and give political support to the resistance from within Africa.

among the masses that we would like to take a stance against imperialist aggression around the world, and if continued they will indeed promote what imperialist countries are advocating. We must clearly oppose this new era of war and occupation which began in 2001 in Afghanistan, and do our part to counter it by organizing, educating and mobilizing masses with a clear antiwar, anti-occupation platform as the colonial powers continue on this bloody path today, in 2011, against Libya.
